## HERITAGE PRESERVATION FILES AND INVENTORY

---

Community Planning and Economic Development (CPED) is located in room #300 of the Public Service Center Building, 250 South 4<sup>th</sup> Street, and retains Landmark nominations and survey forms for properties in the city as well as inventory files for designated districts and other potentially historic properties. Some of these materials are in survey form and typically contain brief descriptions of the resource or building, an approximate date of construction, a statement of significance, and a photograph. For locally designated properties, CPED maintains records on applications that have gone before the HPC for approval, as well as minutes from HPC meetings. There is also a collection of books maintained on the history of Minneapolis.

Survey and research information is available to the public during normal business hours. Those interested in researching any potential or known historic resource are encouraged to call for an appointment with CPED staff to discuss their specific needs or to view the HPC collection.

# Minneapolis Heritage Preservation

## Celebrating 45 Years

**Recognition and Protection**  
Minneapolis designates property as landmarks or historic districts because of historical, cultural, architectural, archaeological or engineering significance. Our current landmarks represent each of these categories, but in recent years we have focused on designating properties that exemplify broad patterns of cultural or social history. The landmarks featured here all have an important social history story to tell and have been elevated through their designation or interim protection as a historic landmark or district.



**North Side Station (2015)**  
The Twin City Rapid Transit Company's (TCRT) last carhouse, North Side Station, opened in 1914. It features a two-story wing that fronts on Washington Avenue North. The first floor provided separate offices for the foreman and clerk, locker rooms for the trainmen, as well as a storage room and paint shop. The second floor appears to have functioned as a "men's club" of sorts; the facility provided a pool room, reading room, and sleeping rooms for use by employees.

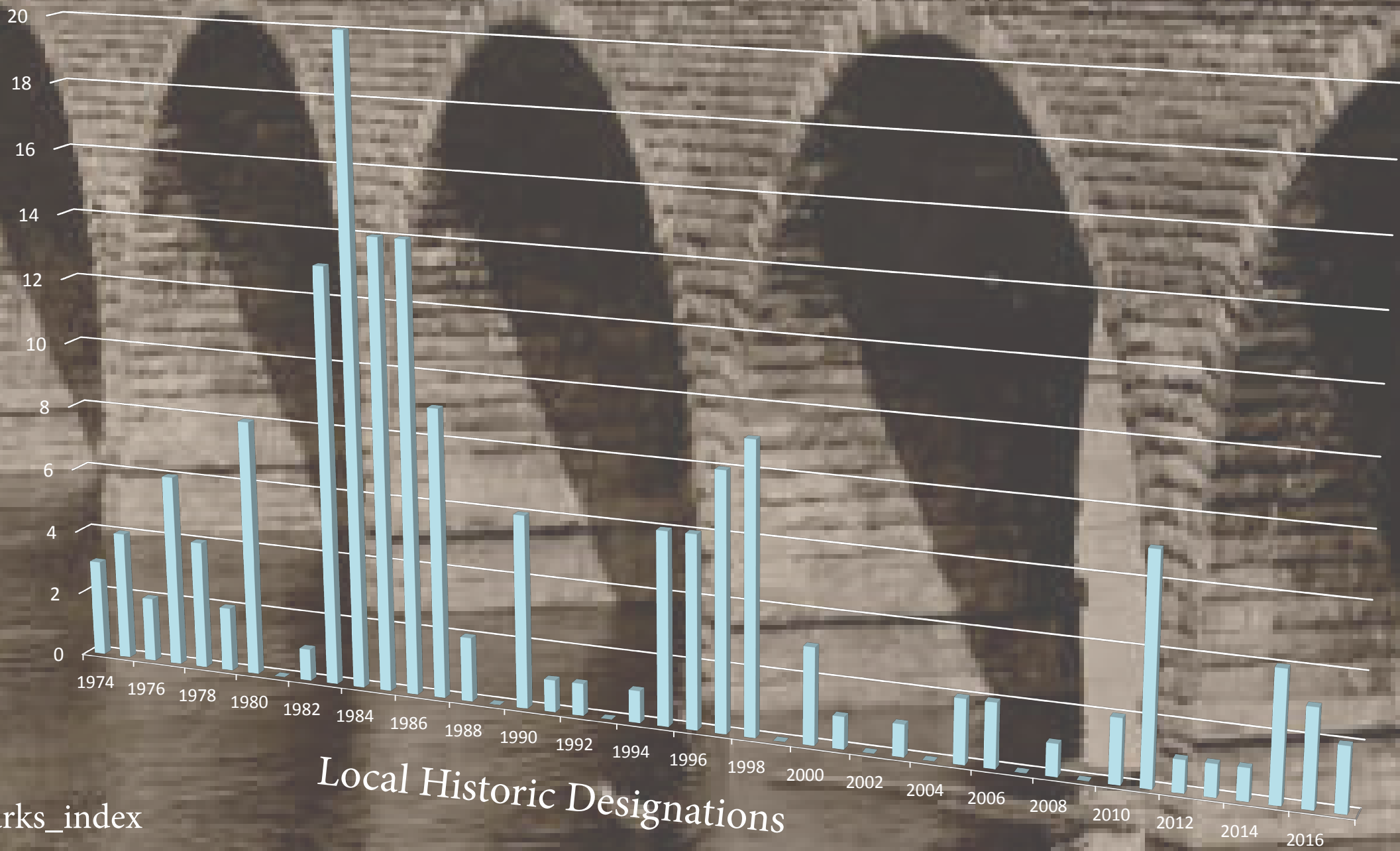


**The Proposed Church of the Incarnation Historic District (Interim Protection)**  
The Church of the Incarnation Historic District is a collection of three buildings historically associated with the Church of the Incarnation parish. The parish, organized in 1909, was the first Catholic church in Minneapolis located south of Lake Street.

## Social History



**Pilgrim Rest Baptist Church (2017)**  
The property is associated with the religious and social history of the Shingle Creek African American community. The early African Americans that settled in this community were former slaves and the children of former slaves who had moved from the South seeking a better life. This small community was geographically isolated from other well-established African American communities in the City.



**Tilsenbilt Homes Historic District (2017)**  
The Tilsenbilt Homes Historic District consists of 28 modest single-family homes that were constructed as part of the first privately developed interracial housing project in Minneapolis, and one of the first housing projects in the country to offer FHA-insured mortgages to buyers of all races. The district is significant for its association with housing segregation and Minneapolis' Civil Rights history, as well as its association with realtor Archie Givens, Sr. and builder Edward Tilsen.



**Arthur and Edith Lee House (2016)**  
In July 1931, a series of menacing riots occurred at 4600 Columbus Avenue South after Arthur and Edith Lee, an African-American couple, purchased and moved into the home. The Arthur and Edith Lee House is associated with the significant events of these 1931 riots, as well as with broad patterns of social history, particularly in regard to African-American history in Minneapolis, race relations, and historical trends of housing discrimination.



## MINNEAPOLIS HERITAGE PRESERVATION AWARDS

Co-sponsored between the HPC, the Minneapolis Chapter of the American Institute of Architects, and Preserve Minneapolis, the Preservation Awards recognize individuals and projects that promote and enhance heritage preservation in Minneapolis. The 27<sup>th</sup> Annual Preservation Awards ceremony and luncheon was held on May 18, 2017, at the International Market Square. The following awards were presented this year:

### HISTORIC RESTORATION, REHABILITATION, OR ADAPTIVE REUSE PROJECT

These are projects that return an existing place, property, building, or landscape to its original character in a manner that is respectful to the property's historic past, or which transform and reinvent the property to incorporate both new and old elements in a way that is respectful of yet different from the form of the past. The following projects received this honor:

- 700 CENTRAL
- HEWING HOTEL

### NEW ADDITION TO AN HISTORIC BUILDING

This category is intended for those where an addition was made to an existing place, property, building, or landscape in a manner that is respectful to the property's historic past. The following project received this honor:

- EMERSON RESIDENCE
- CHARLES FREDERICK KEYES HOUSE

### GRASSROOTS: ADVOCACY AND EDUCATION

This category is meant to recognize individuals and organizations for a range of preservation-related advocacy, education, outreach, and community engagement activities. The following project received this honor:

- 4WORD HOME AND DESIGN, LLC

### THE STEVE MURRAY AWARD

The Steve Murray Award is considered the top individual honor for preservation in Minneapolis. It is awarded to an individual who has displayed leadership, courage, and dedication to heritage preservation in Minneapolis in the last year or over the course of his or her career or lifetime. The following individual received this honor:

## DESIGNATIONS

This year the HPC designated two individual landmarks and one historic district.

### LOCAL INDIVIDUAL DESIGNATIONS

---

#### PILGRIM REST BAPTIST CHURCH

5100 JAMES AVENUE NORTH

DESIGNATION: JANUARY 5, 2017

Pilgrim Rest Baptist Church is locally significant as one of the earliest African American churches in North Minneapolis. The early African Americans that settled in this community were former slaves and the children of former slaves who had moved from the South seeking a better life. This community is significant to Minneapolis's history as it is emblematic of a community that strived for and achieved success, achieving higher rates of homeownership and literacy than nearby European settlers during a period of harsh racial discrimination and segregation (Criterion #1). The church has been an important structure for social events, meetings, entertainment, and as an anchor for the Shingle Creek African American community ever since (Criterion #3).



#### MINNEAPOLIS ARMORY

500 6TH STREET SOUTH

DESIGNATION: MARCH 02, 2017

The Minneapolis Armory is architecturally significant as a premier example of the PWA Moderne style as designed by the St. Paul architect P.C. Bettenburg and built in 1935-36. The Public Works Administration policy of not designing buildings essentially allowed contemporary architectural styles to prevail for its projects. In the case of the Minneapolis Armory, Art Moderne design fixtures are exhibited in the smooth wall finish, rounded pilasters at the two primary entrances, and generally low profile of the building. Inside, two mural paintings by Elsa Jemney and Lucia Wiley, undertaken by the Federal Section of Painting and Sculpture, decorate a room within the former office space. It was designated for meeting local criteria 1, 3, 4 and 6.



### LOCAL HISTORIC DISTRICT DESIGNATION

---

#### TILSENBILT HOMES HISTORIC DISTRICT

28 PARCELS LOCATED ALONG 4TH AVENUE SOUTH AND 5TH AVENUE SOUTH  
BETWEEN 39TH STREET EAST AND 47TH STREET EAST

DESIGNATION: JANUARY 05, 2017

The properties of the Tilsenbilt Homes Historic District were built as part of the first privately-developed integrated housing project in Minneapolis, and one of the first integrated projects to offer FHA-insured mortgages in the nation. The district is significant for its association with housing segregation and Minneapolis' Civil Rights history (Criterion #1) and with two significant individuals: builder Edward Tilsen and realtor and developer Archie Givens (Criterion#2).



## CLG GRANT

In FY 2016 the City embarked upon an effort to funds to prepare designation studies and design guidelines for the best remaining examples of religious institutions significant for their secular contributions to our community, in particular institutions associated with under documented groups. Thanks to a National Park Service grant and a City match totaling \$40,000, CPED continued its efforts to identify and protect a broader, more inclusive segment of our community's heritage, in particular:

- *Plymouth Congregational Church, 1900 Nicollet Avenue* - From its founding in the 1850s by staunch abolitionists, the Plymouth Congregational Church has remained committed to improving the lives of Minneapolitans, to include 1950s neighborhood assistance efforts, 1960s efforts to help deinstitutionalized mentally ill citizens, & 1970s efforts to support lesbians & women suffering from abuse.
- *St. James African Methodist Episcopal Church, 3600 Snelling Avenue* - St. James AME Church traces its roots to Minnesota's first African-American congregation, which began meeting in 1863 in what was then Saint Anthony.
- *Talmud Torah, 1616 Queen Avenue North* - Talmud Torah, founded in 1894, was the first Jewish school in Minneapolis & provided a variety of free social services, particularly to new immigrants.
- *Emmanuel Cohen Center, 1701 Oak Park Avenue North* - Designed by master architects Liebenberg & Kaplan, this building represents significant Jewish-based social services established in Minneapolis.
- *St Mary's Orthodox Cathedral, 1629 5<sup>th</sup> ST NE* - Designed by master architects Boehme & Cordella, St. Mary's Orthodox Cathedral began in 1887 as an eastern-rite Catholic community founded by Carpatho-Rusyn immigrants from eastern Slovakia.
- *Church of the Incarnation Church, Rectory, and Moynihan Hall, 38<sup>th</sup> ST West & Pleasant Avenue South* - The architecturally distinctive buildings in this complex were all designed by masters of their trade: Emmanuel Louis Masqueray; Bertrand & Chamberlin; & Ellerbe & Company.

## PERMITS AND DESIGN REVIEW

The Minneapolis Heritage Preservation Ordinance requires the HPC and CPED staff to review alterations to landmarks, properties within historic districts, and properties under interim protection. Additionally, the ordinance requires CPED staff to review all wrecking and moving permits prior to issuance by the City to determine whether the affected property is a historic resource. If CPED staff determines that the property is a historic resource, the demolition requires approval by the HPC.

### CERTIFICATES OF APPROPRIATENESS

---

The HPC reviewed 33 Certificate of Appropriateness applications.

### HISTORIC VARIANCES

---

The HPC reviewed seven Historic Variance applications.

### APPEAL OF THE PLANNING DIRECTOR

---

The HPC did not review any appeals of the Planning Director.

### DEMOLITION OF HISTORIC RESOURCES

---

The HPC reviewed two applications for the Demolition of a Historic Resource.

### CERTIFICATES OF NO CHANGE

---

CPED staff administratively reviewed 260 Certificate of No Change applications for minor alterations that did not change the historic integrity or visual character of the property.

### WRECKING PERMITS

---

CPED reviewed a total of 87 wrecking permits.
